OPERATION REGULATIONS

The purpose of the regulations is for the better service. By entering and staying at the Camping you comply to abide by the rules and conditions.

To respond to your complaints or remarks responsibly, it is advisable that you should only refer to the reception.

1.Check in at the Reception desk between 8:00 – 23:00. The camper is obliged to deliver the passport or identity card when entering the campsite.

2.Departure from the position is until 12:00. After that, you are charged with a extra day stay.

3.The camping spot is allocated exclusively by the responsible employee of the Camping. Change of position is allowed only with the permission of the Directorate. To place a second tend, and generally, before any change in the initial situation that the reception is aware of, please ask first.

4.Any change in the number of people must be reported immediately in the Reception. Every new person will be charged extra.

5. Visits are allowed following a permit and handing over of the visitor's Identity Card or Passport. For up to six (6) hours, visitors will be charged for one-day stay and, for six (6) to twenty-four (24) hours, they will be charged for overnight stay.

6.Entrance-exit of cars is allowed from 8:00am to 23:00pm. The movement of the cars in the camping is permitted only during these hours. Entrance is prohibited during other hours and the cars will be stay outside of the camping.

7.Entrance to the Camping area is only allowed in the cars whose speed is prohibited to exceed 5 km per hour. Entrance into the campground of any driver exceeding the speed limit will not be allowed again in the future. Besides, the camp's security guard has the right to refuse entrance to any driver who, in his estimation, has consumed a large amount of alcohol or other substances.

8.The car necessarily is parked in the defined parking areas of the camping.

9.During the quiet hours (14:00 to 17:00 and 23:00 to 08:00) each camper is obliged to disturb the others.

10.Pet owners who visit Camping must bring their pet health booklet with them. Pets must be strapped and under the responsibility and supervision of their owners. They are not allowed to move freely or enter the sea (according to the regulations of the Coast Guard) and the restaurants. The owners are obliged to collect the feces of the pets. Camping bears no responsibility for pets that evade the attention and supervision of their owners.

11.In the absence from the campsite it must remove the connection of the caravan to the electricity.

12.The campers are responsible for the cleanliness of their area and asked to keep the camping site clean and to use the specials dustbins. Respect the nature & do not bad to the trees & plants by throwing the dirty water.

13.It is also forbidden to wash dishes and clothes in the water taps used only for drinking water. The above acts are allowed only in the specifics installations.

14.Damage caused by the fault of campers or visitors to facilities or equipment of camping, are charged to the visitors' campers.

15.For the smooth operation of the camp, the safety of campers, and the overall aesthetics of the camp, any intervention-addition both to the campground and to the camping means such as construction, roof, fence, storage, barbecue or any other construction whatever the texture and materials - apart from the caravan, a front tent and one umbrella in each campsite- is strictly prohibited.

16.The company has the right to evict, without a second warning, any campers or visitors who fail to respect the camp's rules and regulations.

17.Lighting of fires throughout the campground or on the beach for cooking or other purposes.

18.The company bears no responsibility for any damage caused by weather, fire, natural disasters or acts of terrorism.

19.The camping is not responsible for loss by theft or damage of any object. Please the campers take care to guard their items.

20.Individual items can be provided for protection at Reception. (with proof)

21.Should the client become ill for any reason, he is obliged to report it immediately to the direction in order to take the necessary measures.

22.For each special announcement the campers will be informed by announcements posted one the special board or by the loudspeaker installations - PA System.

These regulations are based on the law for organized camps.
